

RELEASE AGREEMENT
PLEASE READ CAREFULLY BEFORE SIGNING

This Release Agreement ("Release is given by the undersigned Double Action Indoor Shooting Center and Gun Shop ("Shop"), a Michigan corporation, in consideration of the Shop's shooting ranges ("Range")

1. I, by signing below, acknowledge that I have received, read and fully understand the rules and regulations of the shop.
2. I agree to hold harmless and indemnify the Shop, and its owners, employees, agents, landlord, successors and assigns, for any Loss or damage, including any that results from claims for personal injury or property damage related to or arising out of my use of the Equipment, use of ammunition, or my use and entry of the Range, whether caused by the negligence of the Shop, Shop's landlord, or otherwise.
3. I am aware and understand that use of the use and entry of the Range is an inherently dangerous activity and I agree to accept and assume any and all risk of injury or death whether or not due to the negligence of myself, the Shop, Shop's landlord, or any other persons using the Range or otherwise.
4. I, on behalf of myself, and my heirs and successors, release, waive and agree not to sue, the Shop, and its owners, agents, employees, landlord, assigns and successors, from and for any and all liability for damage or injury to myself or to any persons or property resulting from or arising out of my use of ammunition, and my use and/or presence on the Range, whether caused by the negligence of the Shop, Shop's landlord, or otherwise. I further release the Shop from any and all negligence, gross negligence or action from any third party. I realize that when I am at the shooting range, accidents occur which shall include but not be limited to accidental discharge or intentional discharge by the third party(s) (either with the use of the third party's own weapons or through the use of others). I (individually, on behalf of my estate my successors, etc.) agree to release the shop for any and all actions or injuries. I agree that such release is specifically, but not limited to, injuries which occur while at the Shop (the shooting range, the store or parking lot).
5. All instructions on the use and entry of the Range have been made clear to me and I understand the function and risks of entry and use of the Range
6. I understand this is a legal document which will be enforced to the fullest extent allowed under Michigan Law. If any part of this Release is held by a court of proper jurisdiction to be unenforceable, the remaining portions of this Release shall be enforceable.
7. I sign this Release on behalf of myself, my heirs, legal representatives and successors.
8. I acknowledge that the Shop is relying on the above statement in granting me permission to use and enter the Range area.

I, THE **UNDERSIGNED**, HAVE READ AND UNDERSTOOD THE ABOVE RELEASE AGREEMENT AND I VOLUNTARILY SIGN THE RELEASE. I AM **AWARE** THAT IT **IS A** RELEASE OF LIABILITY AND HAS LEGAL CONSEQUENCES.
